## MERCHANT RULES FOR TRADE FAIR

1. **APPLICATION FORM** – The Trade Fair Application Form is issued by the Grupe Operating Company hereinafter referred to as GOC. No space will be reserved unless a complete form with appropriate fee is submitted.
2. **NEW MERCHANTS** – Please include with your application photos or samples of your merchandise as soon as possible.
3. **OPENING HOURS**

Thursday	9:00 a.m. – 6:00 p.m.- any vendor who wishes to set up early.
Friday	9:00 a.m. – 6:00 p.m.
Saturday	9:00 a.m. – 6:00 p.m.
Sunday	9:00 a.m. – 5:00 p.m.
4. **DISMANTLING OF STANDS** – Please do not remove exhibits or goods prior to 12:00 p.m., Sunday, October 2, 2017, goods **MUST BE REMOVED** by 8:00 p.m., Sunday, October 2, 2017. Merchants are responsible for seeing that ALL items provided to them (i.e. table, chairs, etc.) are in good shape and in the appropriate booth space upon leaving. Merchant will be charged replacement cost of items not in allocated spot or in good condition upon check out.
5. **REFUNDS** – (a) Full refund will be made if the notice of cancellation and request for refund is made, in writing, by August 19, 2017; (b) No refunds will be made after August 20, 2017.
6. **ELECTRICITY** – NO OUTLETS AT THIS TIME. NO GENERATORS, SMOKING, RADIOS, OR DOGS ALLOWED IN VENDOR AREA.
7. **GENERAL CONDITIONS** – Please make sure all (a) (unless prior arrangements have been made) No Merchant will be allowed to place exhibits of any type or description so that any part thereof **projects beyond the limits of the space allotted**, nor in such a manner as to **obscure the exhibits of an adjacent stand**; (b) Every Merchant shall indemnify and save harmless The Grupe Operating Company from any and all claims, demands, damages, actions, costs and charges to which GOC may be subject or to which The GOC may have to pay by reason of any injury to any person or property, or loss of life or property resulting from or in any way connected with, the character, condition, or use of the premises or any means of ingress thereto or egress there from unless such injury or loss arises solely from the negligence of The GOC, and shall at his own expense, assume the defense of such claims and actions for damages arising out of such injuries or losses which may be brought against The Grupe Operating Company by a third person; and shall pay any such judgments that may be rendered in such actions.
8. **INSURANCE** – As a condition precedent to this agreement, all Merchants shall furnish to The GOC proof of comprehensive general liability, workers compensation, and products liability insurance in a form, and in amounts, satisfactory to The GOC. Adobe Illustrator (eps file with embedded fonts and images)  
Adobe Photoshop (300 dpi jpeg or tiff)

**Formats accepted: (Also see below regarding conversions)**

EPS, PDF, TIF, JPEG

**Color files should always be saved as CMYK.**

Scanned photo resolution should be **minimum of 266 dpi / maximum of 300 dpi for full color images.**

**Minimum of 300 dpi for line art. 72 or 96 dpi images are not acceptable.**

All fonts and graphics **MUST** be included with files sent. **MAC Fonts** are the only fonts acceptable. IBM (Windows) fonts are **NOT** acceptable using the above programs. Fonts embedded in file or converted to paths/outlines preferred
